REGISTRATION AGENTS



RAs can benefit from bulk order processing, streamlined Letter of Authority (LoA) management and API for application integration. Deep discounts, including multi-year support and payment monthly in arrears. RapidLEI coordinates a license with the GLEIF to display the GLEIF logo as an “Official Registration Agent” inclusion on the GLEIF website as an Official RA. RA Partners are also licensed to use a RapidLEI Official Registration Agent custom logo, link to a RA Partner profile page and listing on RapidLEI.com.

CLIENT AGENTS



Client Agents order through their own account on behalf of their clients. RapidLEI automates the application and issuance so there is no need for Client Agents to invest in resource heavy administration processes when ordering LEIs on behalf of their own customers. Rebates are available, including multi-year support. Client Agent Partners are also licensed to use a RapidLEI Certified Partner logo.

REFERRAL PARTNERS



Customers order directly via referral links and you earn commission. Simply direct customers to RapidLEI rather than get involved in the LEI ordering process. Referral Partners can also gain access to API for automated application integration. Referral Partners are licensed to use a RapidLEI Certified Partner logo.

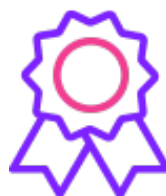

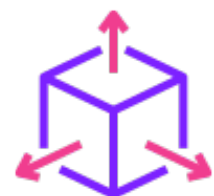

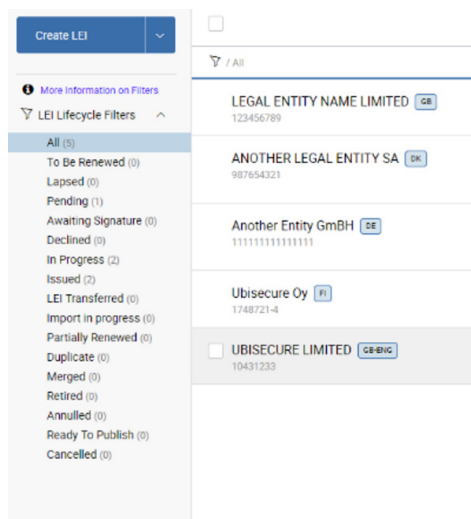
